## ***123/16 Report of the Parish Clerk***

### ***a) Monthly Playground Inspections***

Cllr Rogers reported that Stainsby Meadow play area is fine; however the surface of the Muga has a 6" diameter hole in the surface of the tarmac. Clerk to write to contractor requesting this is repaired as the Parish Council is concerned that the tarmac surface does not comply with the implied terms of the Section 14 of the sale of goods act, as this surface has only been laid for 18 months.

The witch's hat play equipment is squeaking, however this is not a safety issue.

Concerns over parents parking on the road when football matches are taking place were raised, Clerk to contact football teams informing them to ensure all supporters of the teams should be parking in the car parks provided.

### ***b) Dobholes Lane Pavilion Showers***

All three quotations have now been received; Cllr Rogers to compare the quotations and this will be discussed at the next meeting.

Clerk to contact football clubs using the facilities at Dobholes Lane reminding them to ensure that all parents/supports should park in the car park at Stainsby Meadow and not on the road.
