17/19 Report of the Parish Clerk

a) Monthly Play Ground Inspections

The annual playground inspection report has been received from Amber Valley.

It was noted that a complaint had been received regarding the log swing on Stainsby Meadow and subsequently the equipment had been taped off, however, the inspectors report did not highlight this as a safety issue, but will be monitored.

Once the information is collected this will be forwarded to the EPC Consultant who will apply for an Exemption Certificate on behalf of the Parish Council.
